4 Current Year Situation

4.1 Fairnilee/Pinkston

The August Fairnilee race will be relocated to a div 2/3/4 at Pinkston on 6/7 August. To be organised by Chris Harmer of Royal Navy Paddlesports Association with support from Stewart Pitt and Jim Wallis.

Entries are still low, and there is still a possibility of cancellation. It is felt that people are entering later as events are not filling up so far in advance. The price of fuel, the general economic situation, and the risks of catching Covid all have an effect.

4.2 Washburn in September

There is insufficient water in the reservoirs to allow this race to take place. There are other sites that may be affected by the low water levels. Organisers are encouraged to review their situation.

4.3 Acceptance of paddle up entries


There will be an item on the next agenda to discuss the automation of acceptance of paddle up entries at closing date.

5 2023 Calendar

There is a compression of competitions in September partially due the Worlds weekend, and to events trying schedule later.

To make the calendar viable and manageable for the 2023 year, more double division races. E.g., rather than a double division 1 race and a double premier race at one location on separate weekends, run a double div 1/premier race on a single weekend. The same for division 1 and division 2, on the same weekend.

At combined premier/division 1 races there will be no free practice, division 1 paddlers will be a allowed a single organised practice run.

A discussion points at the ACM will surround the number of races at each level. For example, we have 14 premier races this year, traditionally we would only have 9 races to avoid a tie with two individuals getting maximum points

There is a desire to include some form of Extreme competition in more races. The intention is to run an extreme competition at the British Open this year.

Running extreme slalom at lower division races might need a variation of some of the rules. This will be reviewed, and guidance produced. Greg Hitchin is withing the Performance department is responsible for the development of guidelines for Extreme. He will be offered assistance from the voluntary sector.

9 Other Competitions

9.1 Worlds 'Test Event'

The test event for the 2023 will be run on 17/18 September 2022. This will be a joint British Canoeing Events and slalom committee event, so will need support from all the volunteers available. There was a co-ordination meeting last week. Volunteer information will be made available this week, it is expected that BCs Canoe Crew will be involved.

9.2 British Open

The event will be in a championship format but will only be open to British paddlers and will not be an ICF ranking race. Consideration will be given to a Sunday run for those not qualifying for the Sunday final. An extreme slalom may be considered for the Sunday. AG will investigate the possibilities for the schedule, this could be open to non-slalom athletes.

9.3 2023 World Championships

The 2023 World Championship organising committee are now meeting regularly and investigating ways to make the event even more successful than the last Championships held in the UK.

10 2022 Possible Rule Changes

10.1 Canoe Slalom England Talent Programme proposals:

A paper proposing some rule changes to support development in the Canoe classes. Replies to these items have been requested from committee members

- 1. Athletes competing in a different event to which they are ranked must compete in the division below or can apply to be ranked in any division. *Supported*
- 2. Modify the multiplication factor used to calculate points for inquorate Women's C1. Supported
- 3. Remove the concept of inquorate races and always allocate maximum points. *This was not supported by the slalom committee.*
- 4. If an inquorate race is run over the same course as a quorate race from a race from the division above allocate full points to any athlete beating more than a set percentage of those in the division above. *More consideration is needed for this item.*
- 5. Allow a free div 3 C1 entry after promotion from division 4 K1. *Not supported by the slalom committee.* Other proposals to encourage participation may be considered.

11 Other Business

11.1 Llandysul Team Complaint

A complaint has been received about the name of a team at Llandysul event. The team's name was that of an illness, and this upset someone else. This became an issue on the event WhatsApp group. No paddler names were recorded for the team, just the team's name. Paddlers and organisers are reminded that care must be taken in naming of teams, and that if there is a complaint during a competition the team should consider changing the name.

Organisers are also reminded that Event WhatsApp groups should be locked and limited only to a small number of administrators, as in the organisers pack.

Organisers should ensure that the team details are correctly recorded so the members of a team can be identified if required.

11.2 Copyright

Peter Keane wants to scan and upload a 1980s booklet. The opening passage of the book notes that copywrite rests with the BCU Slalom Committee. The committee approved the scanning of the book and republishing on his website.

11.3 Video Judging Equipment

A successful grant application to UK sport means that for the next season there will be the capability to provide video review functionality premier races.

11.4 2023 ITO Nomination

There was a discussion of the criteria used for people to be nominated as Officials internationally. It was agreed to vary the requirements to include the BUCS race in supporting slalom in the UK.

12 Future Meetings

The next meeting will be online Wednesday 14th September followed by a continuation on 21st September. The final meeting of the year will be on Wednesday 26th October principally to discuss ACM business.
