# 7.2 Slalom Disciplinary Regulations

PUK have updated their template regulations ad are asking each discipline to adopt these. A few possible issues were highlighted in the proposed regulations which will be put back to PUK for clarification or amendment. **Action: LF** 

## 7.3 Safety Update

A paddler death (non-slalom) from e coli possibly linked to river pollution was reported. The Environment Agency are looking to the whole issue of river pollution which may impact on water sports in the future. The best mitigation for paddlers is washing hands and face after paddling to reduce bacteria risk. We also need to continue to raise awareness around Weils disease and that the biggest risk is people not wearing shoes on the riverside and when paddling. **Action: LF/PC** 

#### 7.4 Discipline Chairs Meeting Update

There was a conversation about liability for volunteers, with the meeting assured that PUK are there to support volunteer through the processes that are being put in place for events.

James Hinves is now PUK's Disciplines lead, and Steve Lindsey is the new Events & Competition lead. PUK stressed that they are listening to feedback from disciplines.
